## Breck Middle School After-School Program

#### Overview

Students remaining in the building after 3:30 PM must be involved in an adult-supervised afterschool activity or registered for the Middle School After-School Program. The Middle School After-School Program provides a safe, adult-supervised environment for Breck students in grades 5-8 on school days from 3:30 to 5:30 PM.

Students participating in the program meet in the Middle School Library after school where they are provided with the opportunity to study, socialize, and relax after the regular school day is complete.

### **Terms and Conditions**

There is no cost to attend the Middle School After-School Program. However, due to Breck's primary interest in providing a safe and productive after school study environment, attendance is strictly controlled.

Students are eligible to participate in the Middle School After-School Program if one (or more) of the following conditions apply:

- The student is enrolled in a supervised after-school activity that ends before 5:30 pm.
- The student has a sibling at Breck who is involved in an after-school activity that requires a later family pick-up time.
- Parents and/or guardians require regular or occasional after-school supervision due to special circumstances. Please contact the Breck Middle School Office and speak with a member of the administration.

### Registration

If you are interested in having your Middle School student attend the After-School Program, please complete the registration form. Completing the form requires you to provide information about your child, the days they are going to attend, and the reason why it is necessary for them to stay after the 3:15 PM car line pickup time or the 3:25 PM bus departure time.
